SUBJECT: Adherence to Proclamation No. 79, series of 2022 declaring October 31, 2022 as a Special Non-Working Holiday, Presidential Proclamation No. 1236, series of 2021 declaring November 1, 2022 a Special Non-Working Holiday, and Clarification on October 24, 2022 work/class suspension

In adherence to Presidential Proclamation No. 79, series of 2022 and No. 1236, series of 2021 declaring October 31, 2022 as Special Non-Working Holiday and November 1, 2022 as Special Non-Working Holiday respectively, this Office declares October 31, 2022, Monday, and November 1, 2022, Tuesday as Special Non-Working Holidays in the entire Bicol University.

In response however to inquiries about suspension of work/special non-working holiday in Legazpi City on October 24, 2022, in celebration of the Feast of St. Raphael the Archangel, at Legazpi Port District, the Office of the City Mayor of Legazpi City issued Executive Order No. 48 series of 2022, an amendment to Executive Order No. 47, series of 2022. The EO 48, series of 2022 specified that the work suspension shall be in the City Government of Legazpi only while other agencies and instrumentalities within the LEGAZPI PORT DISTRICT are encouraged to follow suit based on their heads' discretion. With this, the Bicol University West and East Campuses have regular work and classes on October 24, 2022.

EXECUTIVE ORDER No. CGBR 48 S. 2022
AN EXECUTIVE ORDER AMENDING EXECUTIVE ORDER NUMBER CGBR
47, S. 2022

WHEREAS, on October 21, 2022, the undersigned issued Executive Order No. CGBR 47, series of 2022;

WHEREAS, it appears, however, that religious activities in celebration of the feast day of Saint Raphael Archangel have been limited due to restrictions as brought by Covid-19;

WHEREAS THEREFORE, the traffic might not be as be as heavy as originally anticipated;

NOW THEREFORE, I, CARMEN GERALDINE B. ROSAL, by virtue of the powers vested in me by law, hereby amends Executive Order No. CGBR 47, s. 2022 as follows:


Suspension of Work. Work shall be suspended only in the City Government of Legazpi. Other government agencies and instrumentalities, and private business establishments within the Legazpi Port District Area are, however, encouraged to follow suit based on their discretion, and should they deem it necessary, in order to afford their employees the opportunity to participate in the above-said religious activities;

Suspension of Classes. Suspension of classes in both private and government learning institutions shall also depend on the discretion of the Department of Education, Commission on Higher Education or the school's administration; and

PNP and PSO Participation. With the foregoing, the PNP and PSO shall impose the necessary level of security to ensure safety and welfare of the participants.

So ordered.
